\$84,647 of the approx. \$105,000 as been paid to Tropical Pools for the renovations out of the reserves account.

We are going over the minimum limit of transactions before incurring fees on ARC deposits. Motion by David Schenkelberg to change the BB & T money market account to an interest bearing checking account in order to avoid these fees. 2nd by Eileen Feiertag.

Motion carries: 7-0 vote

David recommended to Mike Quinn to bundle invoices in the future to avoid fees by the bank.

Jeff Hmara commented to make financials available to residents at the monthly meetings.

Jeff will conduct the meetings in the following format with regard to voting topics: Make motion – board discusses topic – audience comments (2-3 minutes, wait to be called, stay on topic) then the board votes.

Guest Speaker: Steve Marino, Tropical Pools said that the pool will be done Dec. 18th or 19th and ready to start filling with water. Price went up to \$105,000 because he found 8 damaged marine lights (seals corroded), corroded hand rails and ladders needed to be replaced, chemicals drums needed to be put on a concrete slab (not on the ground) for health/safety reasons. Found many valves leaking. Need to be replaced ASAP. Total cost \$3000 includes elements for filtering. Need experienced pool company to keep new pool and equipment serviced in the first year.

Motion by David Schenkelberg to approve additional pool work over budget, 2nd by Eileen Feiertag. Motion carries: 7-0 vote

Motion by Bernie Holmstock to replace valves /elements for pool pumps up to \$3000 with the condition that Mike Quinn get 2 more competitive bids and proceed at Mike's recommendation, 2nd by Joe Gall. Motion Carries: 7-0 vote.

Discussion: Installing a mosaic tile dolphin pattern at the bottom of the pool for a cost of \$980.

Motion by Eileen Feiertag to approve the mosaic dolphins with beach ball pattern for \$1000, 2nd by Bernie Holmstock.

Motion carries: 6-1 vote. David Schenkelberg voted no.

Motion by Eileen Feiertag to pay \$5523 to Allstate Management, our former lakes maintenance company, for the services rendered as stated in the past due invoice. This would release Madison Green Master Association from their lien against us as well as officially terminate their contract. 2nd by Ross Shillingford.

Motion Carries: 6-1 vote. David Schenkelberg voted no.

Revise composited ARC rules and regulations: tabled

Check signatures: all documents filed. Waiting on bank.

Christmas Eve close at 2:00 pm, New Years Eve close at 4:00 pm. 2nd by David Schenkelberg Motion Carries: 7-0 vote.

Motion by Eileen Feiertag to re-establish the ARC Committee: Members Judy Ratka, Liz Shaffer, Jennifer Sandman and Marc Oliveri as an alternate. 2nd by David Schenkelberg.
